Adult Helmet Waiver & Assumption of Risk and Release of Liability

_____ A. I, the undersigned, recognize the inherent dangers of mounting and/or riding equines (horses, mules, burros). I wish to be a Participant at the Arvada Indoor Equestrian Center facilities by mounting and/or riding an equine. I realize I am subject to injury from this equine involved activity and that no form of preplanning can remove all the danger to which I am exposing myself.

_____ B. I have fully read, understood and signed the Sundance School of Riding, LLC (Sundance) and Arvada Indoor Equestrian Center's (AIEC) Assumption of Risk and Release of All Liability.

_____ C. I am aware that Sundance and AIEC require that ALL minors must wear a properly fitted ASTM/SEI riding helmet with the chinstrap securely fastened, at all times, while mounted.

_____ D. I am aware that Sundance and AIEC strongly recommends that ALL adult riders should wear ATSM/SEI approved equestrian helmets at all times while mounted.

_____ E. I am aware that an ATSM/SEI approved equestrian helmet can assist in preventing head injuries and/or traumatic brain injuries in the event of an accident. Despite Sundance and AIEC's policy I am refusing this CRITICAL safety precaution, and I am assuming all risk of injury to myself by my refusal to wear an equestrian helmet.

_____ F. I, the undersigned, on my behalf of myself, my successors, assignees, agents, and my heirs and executors, hereby release, waive, forever discharge, and covenant not to sue Sundance and AIEC and their representative officers, directors, partners, agents, employees, volunteers, sponsors, insurance contractors and other representatives (collectively "Releasees"), for any and all liability whatsoever for any and all damages, losses, or injuries (including but not limited to death) to persons or property or both, including but not limited to any and all claims, demands, actions, causes of actions, damages, losses, injuries, costs, expenses and attorneys' fees, that may be sustained while I am a Participant with Sundance and/or AIEC or any activity carried on by me in connection therewith, **including injuries sustained as a result of the negligence of Releasees.**

_____ G. I, the undersigned, hereby covenant and agree to indemnify and hold harmless Releasees for and against any liability whatsoever for any and all damages, losses, or injuries (included but not limited to death) to persons or property or both, including, but not limited to, any and all claims, demands, actions, causes of actions, damages, losses, injuries, costs, expenses, and attorneys' fees, that arise out of being a Participant with Sundance and/or AIEC or any activity carried on by me in connection therewith, **including, but not limited to, damages, losses, or injuries sustained as a result of the negligence of Releasees.**

I UNDERSTAND THAT SUNDANCE AND AIEC HAVE NO OBLIGATION TO PROVIDE ANY EQUESTRIAN RIDING EQUIPMENT.

I HAVE READ, UNDERSTOOD AND ACCEPT THE ADULT HELMET WAIVER.
